I. COMPANY PROFILE

Rashtriya Chemicals and Fertilizers Limited (RCF) was incorporated under the Indian Companies Act, 1956 with the objective to carry on business relating to production and marketing of fertilizers, industrial chemicals and derivatives. The company has two operating units – one at Trombay and the other at Thal in Raigad District. RCF is a Schedule 'A'/Mini-ratna CPSE in Fertilizers sector with the administrative jurisdiction of Ministry of Chemicals & Fertilizers. The company employed 2635 regular employees (Executives 1298 and Non-Executives 1337) as on 31.03.2022.

Its Registered and Corporate offices are in Mumbai, Maharashtra.

The authorized and paid up capital of the Company was Rs.800 crores and Rs.551.69 crores respectively as on March 31, 2022.

The shareholding of the Government of India in the company is 75%. Disinvestment of 10% paid up equity out of GoI shareholding in RCF through OFS is currently under process.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Technical) is a member of Board of Directors and reports to Chairman and Managing Director. He acts as head of the Technical/Operations Division of the Company. His responsibilities include exercise of control over the efficient operation of the plants of the Company in a manner which would ensure optimum utilization of resources. He also acts as Principal Adviser of the Company in all technical and operations matters.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

The applicant should be an engineering graduate with good academic record from a recognized University/ Institution.

Applicants with Chemical Engineering and or holding MBA/ Post Graduate Diploma in Management will have added advantage.

4. EXPERIENCE:

The applicant should possess adequate technical/operational experience/exposure at a senior level of management in a large organization of repute, out of which at least five years during the last ten years should have been in major production units in Fertilizers/ Chemicals/ Petrochemicals Sector.
