Rashtriya Chemicals and Fertilizers Limited (RCF), a Government of India Undertaking is a leading fertilizer and chemical manufacturing company with about 80% of its equity held by the Government of India. It has two operating units, one at Trombay in Mumbai and the other at Thal, Raigad district, about 100 KM from Mumbai. Government of India has accorded "Mini-Ratna" status to RCF.

RCF is one of the earliest Units set up in the country with a vision of growth in fertilizer production for food security. It manufactures Urea, Complex Fertilizers, Bio-fertilizers, Micro-nutrients, 100 per cent water soluble fertilizers, soil conditioners and a wide range of Industrial Chemicals. It produces 23 lakhs MT Urea, 6.5 lakhs MT Complex fertilizers and 1.6 lakhs MT of Industrial Chemicals every year. The company is a household name in rural India with brands "Ujjwala" (urea) and "Suphala" (complex fertilizers) which carry high brand equity. RCF has countrywide marketing network in all major states. Apart from the own manufactured products, the Company is also engaged in marketing of SSP and imported fertilizer inputs like, DAP, MOP & NPK fertilizers. Besides fertilizer products, RCF also produces almost twenty industrial chemicals that are important for the manufacture of dyes, solvents, leather, pharmaceuticals and a host of other industrial products.

The company has its Marketing Head Quarters at Mumbai. A whole time Director heads the entire marketing operations of the Company, assisted by Executive Director, General Managers and other Senior Officers. The Marketing Set-up consists of Regional offices as detailed in **Annexure –B.** The products are distributed through a wide dealership network through rail and road dispatches.

Urea is a controlled product and the price is fixed by the Government from time to time. The price fixed by the Government is exclusive of all Taxes and other applicable local Duties which are collected at actuals.

Complex fertilizers such as Suphala 20:20:0 and Suphala 15:15:15 are also sold at market determined but at reasonable price for these fertilizers the subsidy is fixed by the Government.

Industrial chemicals sold to Dealers and downstream actual user Industries on Ex.-works price fixed by an internal Committee of the Company to ensure that quality products are made available at reasonable and Competitive prices.
