This is to inform you that Department of Fertilizers, Ministry of Chemicals and Fertilizers, Government of India, vide office memorandum dated October 26, 2023, has announced revised subsidy rates under Nutrient based Subsidy (NBS) scheme applicable from October 1, 2023 onwards. There has been reduction in the rates of the subsidy ranging from 30% to 85% depending upon the NPK fertilizer grades.

Accordingly, under extant NBS Policy, the Company expects an impact on unsold inventory including stocks lying with wholesalers and retailers yet to be sold to farmers and confirmed through Point of Sale (PoS), as on September 30, 2023.

The estimated impact on account of the same is around Rs.374 Crore.
