The bidders shall upload following pre-qualification documents along with their offer as per mentioned in PART-I of e-tender:

1) Work experience:

All the bidders shall submit copies of work-orders with completion certificate, iss ued by their clients, for carry out 3D scanning of components/pipe structure/ pip ing in any industries, during the last seven years ending the last day of month p revious to the one in which this subject tender is floated/issued,

(Bidders shall submit the completion certificate / documents indicating work completion issued by clients, corresponding to the submitted work-orders).

2) Average annual financial turnover during the <u>last three years</u>, ending 3 1st March of the previous financial year (i.e. FY 2020-21, 2021-22 & 2022-23 OR FY 2021-22, 2022-23, 2023-24) should be at least Rs. 5.15 Lakhs.

The Turnover should be issued by practicing CA with membership number, seal, signed and with UDIN.

- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
