DEBARMENT ORDER

Sub: Debarment of M/s. Total Sea-Land Logistics Pvt Ltd for Suo moto withdrawal from tender during bid validity period.

Ref: GEM Bid No. GEM/2025/B/5874897 Dt. 27.01.2025 for Screening of urea product to get sieved urea for Sulphur Coated (Gold) Urea product in Bagging and Material Handling section of RCF, Trombay Unit.

We refer to the above-mentioned tender, for which you had submitted your techno-commercial offer. After techno-commercial scrutiny and price bid opening, you emerged as the Lowest bidder after the conclusion of the e-Reverse Auction (e-RA), conducted on the GeM portal.

However, in your email dated 28.04.2025, you mentioned that the L1 rate of ₹28,14,193.80 (including GST) was quoted incorrectly due to an oversight. In response, vide email dated 09.05.2025, RCF informed you that we would proceed with the placement of the order as per your offered price, since it is within the bid validity period. We also cautioned that withdrawal of your offer within the bid validity period would attract action as per the terms and conditions of the bid document. Despite this, vide email dated 12.05.2025, you expressed your constraints in accepting the quoted price, and that you will not be able to execute the tender at the quoted price.

A Show Cause Notice dated 14.05.2025 was issued to M/s. Total Sea-Land Logistics Pvt Ltd, requiring you to explain your actions within 7 days. The notice also informed you regarding the consequences of your actions, including forfeiture of their Earnest Money Deposit (EMD) and debarring you from participating in future tenders.

Vide email dated 16.05.2025, you reiterated that your incorrect bid was due to a clerical error resulting from an oversight in calculations. You confirmed that RCF is free to take any action deemed necessary, and you will honor such action without any dispute.

RCF Ltd. has reviewed your actions and informs you as follows:

1. M/s. Total Sea-Land Logistics Private Limited has been put on RCF's debarment list for a period of 6 months from 13.06.2025 to 12.12.2025, thereby disqualifying you from participating in future tenders.
2. The Earnest Money Deposit (EMD) of ₹ 3,00,000 submitted by M/s. Total Sea-Land Logistics Private Limited against the tender will be forfeited.
3. Contracts awarded before the issue of the debarment order shall, not be affected by the debarment Orders.
